L.O.L. SURPRISE!TM FASHION SHOW CONTEST RULES

THE L.O.L. SURPRISE![™] FASHION SHOW CONTEST (THE "CONTEST") WILL BE CONDUCTED IN CANADA (EXCLUDING QUÉBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of Canada (excluding the province of Québec); and
 - (b) be of the age of majority in their province or territory of residence or older at the time of entry.
- 1.2 The following people are not eligible to enter the Contest:
 - (a) Employees of Corus Sales Inc., its parent, affiliates, subsidiaries, related companies, successors and assigns (collectively "**Corus**" or the "**Sponsor**");

- 1.3 The Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsor for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.
- 2. CONTEST PERIOD. The Contest begins at 12:00a.m. Eastern Time ("ET") on October 9, 2022 and ends at 11:59 pm ET on November 6, 2022 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (a) To enter online, complete and submit the entry form located at <u>www.ytv.com/lolsurprisefashionshow</u> (the "**Contest Microsite**").

- 3.2 Limit of one (1) entry per person per day during the Contest Period. In the case of multiple entries per day, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsor and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Official Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsor with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZES.

- 4.1 There are five (5) prizes (each, a "**Prize**", collectively the "**Prizes**") available to be won by the Prize winners (each a "**Winner**", collectively the "**Winners**"). Each Prize will consist of:
 - (a) Two (2) L.O.L. Surprise! O.M.G.TM Fashion Show Hair Edition dolls;
 - (b) Two (2) L.O.L. Surprise! O.M.G.[™] Fashion Show Style Edition dolls.
 - (c) Twelve (12) L.O.L Surprise! O.M.G.[™] Fashion Show Collectible dolls; and
 - (d) One (1) L.O.L. Surprise! O.M.G.TM Mega Runway playset.
- 4.2 Each Prize has an approximate value of five hundred Canadian dollars (CDN\$500).
- 4.3 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 Prizes will be distributed within Fourteen (14) days after each Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsor and MGA. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsor and MGA shall have no obligation to provide either an alternative or value-in-kind. The Sponsor and MGA reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- 5.2 Shipped Prizes shall not be insured and the Sponsor and MGA shall not assume any liability for lost, damaged or misdirected Prizes.

6. WINNER SELECTION.

- 6.1 Five (5) Winners shall be selected as follows:
 - (a) On or about November 7, 2022 in Toronto, Ontario, five (5) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received the Sponsor. Before being declared a Winner, each selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).

Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsor's sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsor is are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsor to receive a selected entrant's response.
 - (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. RELEASE. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.
- **13. TERMINATION.** The Sponsor reserve the right, in its sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsor. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsor in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
- **15.
